Ordinance no. 44 by the Jagiellonian University Rector of 27 June 2019

on: establishing doctoral programs in the Doctoral School in the Social Sciences

Pursuant to Art. 23 (1) of the Act of 20 July 2018 – Law on Higher Education and Science (O.J. of 2018 item 1668, as amended) concerning § 4 (10) Rules and Regulations of the Doctoral School in the Social Sciences which constitutes Annexe no. 2 to Act no. 27/IV/2019 of the Jagiellonian University Senate of 24 April 2019 on doctoral schools rules and regulations I hereby order as follows:

§ 1

Starting from academic year 2019/2020 the following doctor programs will be established in the Doctoral School in the Social Sciences:

- 1) doctoral program in social sciences in the domain of Economics and Finance which constitutes Annexe no. 1 to this Ordinance;
- 2) doctoral program in social sciences in the domain of Socio-Economic Geography and Spatial Planning which constitutes Annexe no. 2 to this Ordinance;
- 3) doctoral program in social sciences in the domain of Social Communication and Media which constitutes Annexe no. 3 to this Ordinance;
- 4) doctoral program in social sciences in the domain of Political and Public Administration Sciences, which constitutes Annexe no. 4 to this Ordinance;
- 5) doctoral program in social sciences in the domain of Management and Quality Sciences which constitutes Annexe no. 5 to this Ordinance;
- 6) doctoral program in social sciences in the domain of Legal Sciences which constitutes Annexe no. 6 to this Ordinance;
- 7) doctoral program in social sciences in the domain of Sociology which constitutes Annexe no. 7 to this Ordinance;
- 8) doctoral program in social sciences in the domain of Pedagogy which constitutes Annexe no. 8 to this Ordinance;
- 9) doctoral program in social sciences in the domain of Psychology which constitutes Annexe no. 9 to this Ordinance;
- 10) doctoral program in social sciences in the domains of Economics and Finance, Socio-Economic Geography and Spatial Planning, Social Communication and Media, Political and Public Administration Sciences, Management and Quality Sciences, Legal Sciences, Sociology, Pedagogy and Psychology named cross-disciplinary program "Society of the Future" which constitutes Annexe no. 10 this Ordinance;

11) doctoral program in social sciences in the domains of Psychology, Humanities, Philosophy, Exact and Natural Sciences, Biological Sciences, Medical Sciences and Health Sciences named International Doctoral Program in Cognitive Neuroscience which constitutes Annexe no. 11 this Ordinance.

§ 2

The doctoral programs mentioned in § 1 shall be governed and and their ongoing activities shall be organized by heads of individual doctoral programs.

§ 3

This Ordinance shall enter into force on the day of its signing.

- 5. Form of credit, duration and number of ECTS points granted for completing a course at the Jagiellonian University are specified in course syllabus.
- 6. Number of ECTS points granted for completing a course or training outside the Jagiellonian University is agreed by the Head of the Program on the basis of PhD student's declaration concerning work involved, i.e. Number of contact hours, remote work and own work required for passing the course or training. Thirty didactic hours equal 1 ECTS point.
- 7. In case of acquiring competence not listed in Table 2, Head of the Program, in consultation with supervisor and Doctoral Committee, decides about the number of ECTS points.
- 8. A given activity (e.g. writing a scientific paper) may be a proof of acquiring several LO, however for this form of verification ECTS points can be granted only once.
