BUDAPEST

Thursday – Friday, 6-7th of October 2022

The arrival of the participants to Budapest is scheduled for the 5th of October (Wednesday) and the departure for the 8th of October (Saturday).

The conference aims to gather young researchers and PhD students from selected scientific disciplines and legal branches and provide them with an opportunity to present their research results in English **in the form of an approximately 25-minutes-long presentation** before an international audience consisting of senior and junior researchers. The participants will have the chance to present on the following topics:

- Certain issues of adoption in the light of the European Convention on Human Rights Law
- Development of Space Law in the Central and Eastern European Region
- Financial Autonomy of Local Self-Governments
- Legal Position and Rights of the Consumer in the Event of a Lack of Conformity of the Goods with the Contract
- Legislative framework of the crime of torture in the regulation and jurisdiction of certain Central European countries
- Protection of the Environment in National Constitutional Law in the light of the Jurisdiction of the ECHR
- Theoretical and Practical Issues of Human Reproductive Procedures

Each topic will constitute a separate panel within the conference. Particular panels will be organized by participants of the Central European Junior Programme, conducting research in the given field.

SCIENTIFIC JOURNAL

In connection with participation in the conference, there will be a commitment for participants to publish their research results in the form of scientific articles in the **Central European Academy Law Review**. The Review provides a free linguistic proofreading services for the participants that will be accepted in the journal.

(In situations when there is no possibility to publish an article in the aforementioned Review, the authors will have the opportunity to publish the work in other journals of the University of Miskolc.)

DETAILS OF THE SCIENTIFIC SECTION OF THE CONFERENCE

MEDICAL LAW - QUESTIONNAIRE

1. **Legality and accessibility of assisted reproductive procedures** (Which legal act regulates ARP? What ARP are permitted (ICSI, IVF)? Who can have access to ARP (heterosexual couples, same sex couples, single woman)? What are the legal limitations on ARP access? Are ARP with third-party donations permitted (sperm, egg, egg and sperm, embryo donation)? What are the legal limitations on ARP access with third-party donations?)
2. **Anonymity in third party donations** (How strict is the anonymity regulation on the donor's identity (both gamete and sperm donors)? What information is available about the donor? To whom is the information available (recipient, the child born)?
3. **Public funding of ARP** (Is public funding granted both in public and private health facilities? Is public funding depending on success rate? Is there a limited number of publicly funded cycles per couple/single women? Are all ART techniques publicly funded?)
4. **Fertility preservation** (Is Cryopreservation of gametes permitted? Under what conditions?)
5. **Legal parenthood** (Can a gamete donor be considered as a legal parent of a child conceived through ARP? Can the fact of ARP procedure establish presumption of maternity/paternity?)
6. **Legality of surrogacy in different countries** (Is surrogacy legal in the chosen country? What type of surrogacy is allowed (gestational, traditional)? Is it altruistic or commercial? Is surrogacy allowed on the basis of medical infertility or other reasons f.e. aesthetic? Has surrogacy been the subject of jurisprudence/court cases in your country?)
7. **Cross-border surrogacy** (Who is recognised as the legal parent of a child born following surrogacy? Is the existence of a genetic link required for establishing paternity/maternity? Who are listed as the parents on the birth certificate? Are foreign birth certificates in surrogacy cases registered in your country?)
8. **Criminal law approach** (Can the intended parents, the surrogate mother, gamete, donor, facilitator be criminally charged? On what legal basis? Where there any criminal cases arising from surrogacy/ARP in the country? Are you aware of the following unlawful practices in your country? (remuneration of the surrogate, remuneration of the gamete donor, advertising for surrogacy services, remuneration of facilitatorse, any other unlawful practices)
